a. Vestry members review the treasurer's report and the floor is opened for questions.

Report of Stewardship Committee

a. The committee plans to make follow up calls regarding yearly pledges. At the current moment, we are at 70 pledges and anticipate a few more. Last year we had a final number of 72 pledges.

Report of Finance Committee

- a. Michael is meeting with Laura this week to go over the budget. There will be upcoming November and December meetings so that there will be a report for the December Vestry report.
- b. Their upcoming meetings will review this past year and what the plan will be for the upcoming year.

6. Buildings & Grounds Committee

DeuPree

- Fr. Christopher thanks the committee for their work getting the gutters fixed and working.
 - a. Joe reminds the group that a number of bids for repairs have been solicited and one bid has been selected to potentially go with.
 - i. The seals on many are deteriorating and will need to be replaced soon. A few interior doors need to be painted. In some areas drywall needs to be replaced as it is peeling. The nave wall needs to be power washed
 - ii. The repairs come out to roughly \$25k. There is about \$24k in our capital maintenance fund and Joe proposed we allocate that money towards repairs. We transfer out \$5,000 for repairs each year, and we have not yet transferred that amount this year.
 - iii. Joe mentions one risk

Ruth and Rusty speak on CERT (Citizens Emergency Response Training) and the prior threats sent to us by an individual who disagreed with our Black Lives Matter sign. Ruthie speaks on her recent experience with CERT.

- a. Ruthie suggested that we try and find people who would want to sign up and attend an AED/CPR class. We can add attendees at a later date but we need to first meet the minimum requirement to have the training.
- b. Ruth and Rusty will continue to explore this to know how St. Thomas can remain prepared for any emergency situations.

7. Mission & Ministry Committee

Hering

a. Mission outreach are working focusing on Ewing House as far as external outreach goes, and they are working on more internal outreach as well.

8. Guild Liaison Reports

 - i. Trying to get one or two more thurifers trained.

 - i. Two participants were sick last week and thus unable to visit, so there is a need for more.

9. Rector's Report Rector

- a. Some formal papers and certificates regarding Allen need to be reviewed. His ordination exams are in January.
 - i. Those online will need to come in person to sign before Allen is in town the week of Thanksgiving.
- b. Two months worth of water bills are included in Vestry information for the group's review.

- The bill has been lowered to a much more normal range thanks to the repair of our water meter and we have been reimbursed for some of the months that were logged incorrectly.
- c. New members were confirmed after the last Anglican 101 class.
- d. A new class will begin for advent relating to Christian nationalism.
- e. A Mardi Gras party will take place January 7th at Wynne's house for those who would like to join.

Fr. Christopher addresses church attendance and wants to discuss this challenge with the Vestry.

- a. The 10:30 service averages about 50 people, whereas we were averaging about 80 before the pandemic.
- b. The question posed is: How do we get people reengaged in church and post pandemic? The goal is to engage parishioners further, and encourage them to fulfill their baptismal covenant.
- c. Solutions suggested are:
 - i. Leadership modeling the changes they want to see
 - ii. Engaging people in activities so that they feel a sense of belonging and responsibility to attend.
 - iii. Checking in and promoting St. Thomas on social media
