1. Call to Order Rector

Meeting was called to order at 7:03 p.m. by Fr. Christopher Thomas with a prayer.

### 3. Reflection/Formation

Deacon Jennifer opened the meeting with the poem *The Orchard* by Mary Oliver, and then facilitated the group contemplation and discussion.

### 4. Prior Meeting Minutes Approval

Senior Warden

Upon motion by John Van Buskirk, and seconded by Ruth Woodward, the Vestry unanimously approved the January 17, 2023, meeting minutes.

### 5. Invite Welcome Connect presentation

**Guest Molly Wills Carnes** 

Episcopal evangelist, LGBTQ+ advocate and author, Molly Wills Carnes, shared her experience with Invite Welcome Connect, a uniquely Episcopalian evangelism model. Ms. Carnes was Connections Missioner at St. Mary's Episcopal Church in Cypress, Texas, for three years, and her ministry is marked by deep empathy for those by wounded by their church experience.

#### 6. Budget & Finance Committee, and Approvals

Treasurer

Committee Chair Joe Deupree presented the report, and two related motions were presented, discussed, and approved.

The first discussion was that including Endowment Fund information in the Income and Expense Statement presents an inaccurate financial picture. The Endowment Fund is an investment account, and gains and losses should only be recognized when they are actually realized (i.e. cashed in).

Upon motion by Jerry Knight, and seconded by John Van Buskirk, the Vestry unanimously approved that the Endowment Fund will not be reflected in the Income and Expense Reports, beginning January 1, 2023, and going forward.

The second discussion was that, in addition to the banking resolutions we provided, Inwood Bank uses its own banking resolution form, and upon motion by Jerry Knight, and seconded by

Janet Elsea, the Vestry unanimously approved the Inwood Bank supplemental banking resolution on the required banking resolution form of Inwood Bank.
